The Net Purse will consist of all nomination fees, sustaining fees, late fees & unused drug testing fees plus the added money (the "Gross Purse"), less \$20,000 for nominator and breeder awards and 13% of the Nomination Payments for administrative and advertising expenses. Nominator and Breeder Awards will pay 10 places using purse distribution scale. Added money for each race will be provided by Remington Park Horsemen's Purse Account allocation for stakes races. The winner of the final will receive a blanket, and trophy buckles will be awarded to the winning owner, trainer, and rider. Credit card payments will have a 3.5% convenience fee.

2020 Oklahoma Futurity and Derby Race Conditions

RACE CONDITIONS

Added Money and Conditions Subject to OHRC Approval

In addition to Paragraph 2 of these Race Conditions and as a condition for participation in this race, and subject to approval of the OHRC in accordance with Chapter 45 Prohibited Practices and Equine testing, all horses nominated to OQHRA Administered futurities or derbies may be subject to drug testing by the OHRC. Any prohibited medication positives may result in loss of eligibility to participate in trials or finals as determined by OHRC Stewards. If pre-race examination or drug testing prior to or following a race is refused by owner or trainer of eligible horse and results in the horse being ineligible to participate there will be no refund of payments. **Eligible participants will be required to comply with a requirement for hair testing prior to entry if such requirement is imposed by the racetrack and approved by the OHRC.**

1. ELIGIBLE HORSES. Quarter Horses, born in 2017 for Derby or 2018 for Futurity, which are registered with American Quarter Horse Association and which are owned or nominated by owners which agree to the special terms of Paragraph 2. Drug Testing, are the only horses eligible to enter the race. An owner may nominate as many horses as desired. If one or more nominations are withdrawn prior to the running of the trials, it is the owner's responsibility to specify which horses are being withdrawn and which horses are to remain eligible when making payments. Either copy of the registration certificate or the application for registration must be provided by the owner/nominator no later than the due date for the January payment if the horse remains eligible.

2. DRUG TESTING. All horses nominated and remaining eligible after payment of the January payment will be required to comply with the pre-entry hair testing requirement. **ADDITIONALLY, THE TOP 25 qualifiers for the 2020 Futurity based on trial times will have hair collected and re-tested after the trials and prior to the final. Any horse failing to produce a clean hair test free of prohibited substances will not be eligible to enter the final regardless of the qualifying time.** In the event the host track implements a pre-entry requirement for hair testing, all eligible horses will be tested in accordance with those rules. The initial fee required for this race to cover the cost of drug testing will cover all hair testing costs for pre-entry to trials and/or final. In the event there is not a pre-entry condition by the track, all owners of nominated horses hereby agree and acknowledge their agreement with the payment of appropriate fee to nominate each horse and the required drug testing for each horse nominated to this race program. Nomination and payment of fees is an agreement that they willingly participate and will cooperate in collection of samples for testing implemented by OQHRA as race sponsor. In the event of an ownership transfer at any time prior to the trials, the new owner must comply with the testing requirements for the eligible horse or the horse will be ineligible to enter trials and the new owner will not be entitled to any refund of fees paid to date. Testing in accordance with this condition is not supervised by or under the regulatory authority of the OHRC. All sample collecting and testing will be conducted by service providers and testing laboratories contracted by OQHRA as race sponsor. All eligible horses as set forth in these conditions will be tested and each owner or trainer will be notified of the horses' eligibility to enter and participate in the trials or final based on the test results prior to time of entry. Any horse tested and not receiving a clean hair test free of prohibited drugs will not be eligible for entry into trials or final of this race and the determination is not subject to an appeal to either the track or the racing commission. In addition to the nomination and sustaining payments in accordance with the payment schedule, at the time a horse is originally nominated each owner or nominator must pay a drug testing fee of \$250.00 in addition to the scheduled payment to be eligible for the race. The purpose of hair testing is provide assurance to all participants that the performance of participating horses is not affected by prohibited or performance enhancing substances and also to eliminate horses testing positive for prohibited substances including but not limited to blood doping agents, Clenbuterol, Zilpaterol, Ractopamine, animal venoms, growth hormones, anabolic steroids, and other drugs or substances that are detected in the hair sample. All testing will be conducted by a Laboratory selected by OQHRA as the race sponsor. Collection of samples will be conducted by a veterinary service selected by OQHRA as the race sponsor. For the purposes of this section all testing will be done on hair taken from the nominated horse. Each horse will be individually identified by a qualified individual prior to collection of the hair sample as determined by OQHRA as race sponsor. No owner, trainer or other person having the care of an eligible horse shall refuse to present the horse for collection of the hair sample at such time and location directed by the OQHRA as the race sponsor. Horses must be timely produced for testing at the location designated by OQHRA. Failure to present a horse for testing or to cooperate with the testing process will result in the horse being disqualified and ineligible to start in trial or participate in the final. Horses that are declared ineligible to enter will not receive a refund of any payments made prior to the time the horse is tested and will be disqualified and ineligible to enter for trials. All horses remaining eligible as a result of a nomination or sustaining payment on or before the due date for the January payment will be provided information on scheduled times and locations for pre-trial entry testing. In the event testing of all horses as specified in this paragraph is not performed due to unforeseen circumstances, the Drug Testing fees will be added to the Net Purse for the final.

3. PURSE. The Net Purse will consist of all nomination fees, sustaining fees, late fees, and any funds remaining from Drug Testing Fee after payments for identification, collection, shipping, and testing plus the Added Money (the "Gross Purse"), less \$10,000 for nominator awards and \$ 10,000 for breeder awards and 13 % of the Nomination Payments for administrative and advertising expenses. Finals purse, Nominator, and Breeder Awards will pay 10 places (40-17-11-9-7-5-4-3-2-2%). Non-sponsor Added Money for each race will be provided by racetrack Horsemen's Purse Account allocation for stakes races. The winner of the final will receive *(a blanket, and trophy buckles will be awarded to the winning owner, trainer, and rider.)* Interest earned, if any, on the escrowed

purse funds after payment of any bank service fees will go to the race administrator. In the event payment is made by Credit card, payments will include an added 3.5% convenience fee.

4. PAYMENTS. Except as provided herein, the failure to make all payments on or before the designated dates will result in a termination of the nomination and all prior nominating and sustaining payments will be forfeited. All payments must be postmarked no later than the due date and should be sent by registered or certified mail. The sender's receipt must be date stamped by the United States Postal Service and presented as proof of mailing if date discrepancies occur. Postage metered dates will not be accepted if payments are not received by the due date. United States Postal Service date stamped metered mail will constitute evidence of mailing if dated, mailed, and stamped on or before due date. All returned checks constitute no payment. In the event a sustaining payment is late (the "Late Payment"), a nomination of the Eligible Horse will not be terminated if, on or before the due date of the next immediate sustaining payment (or the entry date if the Late Payment is the last sustaining payment), the person nominating the Eligible Horse pays (a) such next sustaining payment; (b) the Late Payment; and (c) an additional amount equal to the Late Payment. The foregoing provision will not apply to consecutive sustaining payments. The initial nomination payment by each eligible horse must be accompanied by an additional fee for Drug Testing. The drug testing fee is non-refundable once a horse is nominated to the race.

5. SUPPLEMENTARY NOMINATIONS. No Late Nominations or supplemental nominations will be accepted after the due date for the January payment. Payment must be made at time of supplemental nomination either by cashier's check or other immediately available funds and must include the Drug Testing Fee. There will be no time of entry late supplement to these races.

6. ENTRY. Entries in all races must be made through the entry box at Remington Park Racing Office by closing time for entries in that race. Nominations to the race do not guarantee the availability of stalls at Race Track for nominated horses. In accordance with OHRC 325:25-1-5 for entry back in the final, a finalist that is physically disabled or dead may be entered for purse payment purposes.

7. TIME TRIALS. In the event there are fewer than 16 trials all trials may run on one day. In the time trials, horses shall qualify on the basis of time and order of finish. The times of the horses in time trials will be determined only to the limit of the timer, the only exception is when two or more horses have the same exact time in the same trial heat. Then the order of finish shall also determine the preference in qualifying or the finals. Except in the case of a disqualification, under no circumstances shall a horse qualify ahead of a horse that finished ahead of that horse in the official order of finish. Should a horse be disqualified for interference during the running of a time trial, it shall receive the time of the horse it is immediately placed behind plus one hundredth (1/100) of a second, or to the maximum accuracy of the electronic timing device. No adjustments shall be made in the times recorded in the time trials to account for head wind, tail wind, off-track, etc. In the event of a timer malfunction of a trial race, the Stewards will use the technological aide of video frame by frame analysis to assign times to each participating horse in that trial. Every qualifier eligible to enter the final will be required to remain on the grounds and stabled in the barn area of the racetrack after the trials and until the running of the final.

8. FINALS. The finalists for the Futurity will be determined by taking the ten (10) fastest times from all the trials. If the number of time trial entries is sufficient as to cause the track to schedule two days of time trials, the five fastest qualifiers from each day will advance to the final. Every qualifier eligible to enter the final will be required to remain on the grounds and stabled in the barn area of the racetrack after the finals and until the running of the trials. The finals will consist of a field of no more than ten (10) horses unless otherwise determined within these conditions. In addition to the pre-entry hair testing, **the fastest 25 qualifiers for the 2020 Futurity based on trial times will be required to comply with collection of another hair sample which will be collected and tested after the trials and prior to entry for the final. Any horse failing to produce a clean hair test free of prohibited substances will not be eligible to enter the Final or the Juvenile regardless of the qualifying time.** In the event ten (10) or fewer horses are eligible prior to the trials, participation in the trials will not be required to qualify for the finals. OQHRA may determine that In the event not more than 12 horses are eligible to enter trials, there may be no trials and a 12 horse gate may be used for the finals with the 11th and 12th place horses receiving no money. Horses running in trials which do not qualify with one of the 10 fastest times to the Futurity Final will be preferred for entry in the Juvenile with preference for fastest non-qualifying times. None of the top 25 horses failing to provide a clean hair test from the post-trial testing will be eligible to enter the Juvenile. No purse money will be paid to Juvenile entries that are scratched for any reason prior to running of the Juvenile. Any remaining purse money with respect to such withdrawn horses will be distributed proportionately to those horses running in the juvenile in accordance with purse distribution percentages.

9. Ties. In the event that all trials are conducted on one day and a tie for the 10th fastest time occurs, 11 horses will be allowed to run in the final. If more than two horses are tied for 10th place, the final two positions will be determined by lot. In the event the trials are ran over two days and a tie occurs for the 5th fastest time on one day, the same rule would apply. If an 11-horse field is ran in the finals the purse will be adjusted accordingly. No more than 11 horses will run in the final if trials were conducted.

10. SCRATCHES. If a horse is ruled ineligible by the stewards or the Oklahoma Horse Racing Commission for entry into either the trials or the final or if the stewards scratch or disqualify a horse from either a trial or the final described herein for a rule violation, such horse may be ineligible for receipt of any purse money. After the entry date for the finals, the purse money that might have been due to such horse will be divided proportionately (based on purse percentages) among the other starters in such race. If, after the entry date for such race, one or more horses are withdrawn from the final for any reason other than ineligibility or a rule violation, the purse monies (in inverse order of finish) equal to the number of withdrawn horses for such race will be distributed

equally to the owners of the horses withdrawn from such final. If, prior to the entry date for the final a horse is ruled ineligible for the final as provided above, the next eligible horse may be entered in such race.

11. JUVENILE. For two-year-olds: 300 yards, first preference given to participants in the (futures) time trials based on fastest qualifying times for horses that did not qualify to the Futurity Final then open to all. Scratched horses in the finals of the Juvenile will not receive money. Any remaining purse money with respect to such withdrawn horses will be distributed proportionately to those horses running in the Juvenile in accordance with purse distribution percentages.

12. NOMINATOR AND BREEDER AWARDS. Recipients will be notified after the running of the finals and must provide a W-9 to claim their award. Any awards or funds which remain unclaimed at the end of the calendar year in which the race is run will be added to the gross purse for the respective race in the next calendar year.

13. RACE DATES. The race sponsor reserves the right to reschedule, postpone, revise the conditions for, or cancel the race for any reason that it deems sufficient. Any nomination to the race may be refused without liability by the race sponsor for any reason at any time prior to the actual running of the final race. If the race is canceled, all nominating and sustaining payments theretofore paid, less the amounts deducted for advertising, accounting, membership and administrative expenses, will be refunded.

14. CHANGE OF ADDRESS. The owner of a horse nominated to the race is responsible for notifying race sponsor of the sale of a horse nominated to the race or of a change in the owner's address.

15. SPONSOR. The race is sponsored by OQHRA. All disputes as to the eligibility to participate in the trials for this race will be determined in the sole discretion of OQHRA and the decision of OQHRA will be absolute, final and binding.

16. RACING RULES. The race date and the race conditions are subject to approval by OQHRA, the racetrack, and the Oklahoma Horse Racing Commission. The decision of the stewards or the Oklahoma Horse Racing Commission in all matters under their jurisdiction will be final. Nominations are accepted only on the condition that those persons nominating or starting a horse in the trials and the final agree to abide by these race conditions, the rules and regulations promulgated by Remington Park, the Oklahoma Horse Racing Commission Rules of Racing (Pari-mutuel), and all other rules, regulations and conditions promulgated by the Oklahoma Horse Racing Commission or any other applicable governmental authority or the race sponsor.
